Under the overall supervision of the MCHC PSS counselor the community mobilizer will be responsible to:

Provide information and awareness raising on MCHC services to women in the community on a need basis.
Assist women and girls coming to MCHC that require psychosocial support.

- Conduct meetings with local stakeholders to increase the level of acceptance and strengthen relationships.

• Provide Psychological first aid and psychosocial support to women and link them to other services available at MCHC such as PSS case management and psychosocial support services

- Co-facilitate group activities in close coordination with staff at MCHC
- Coordinate with the PSS counselor and provide support in tasks related to MCHC.
- · Provide supportive information to women and refer them to available services within MCHC.
